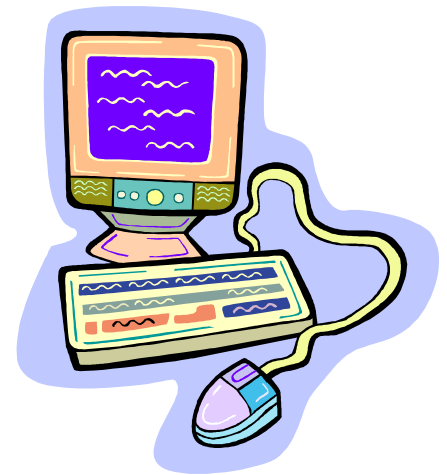

I can't wait for the summer when I can go outside and play. I am going to try and learn to ride a bike this year. I have one with training wheels so I don't fall. Have a great summer!



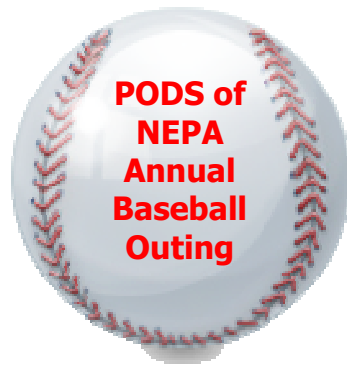

## **The Arc PA Action Alert - Oppose SB850 Right Now!**

**SB850 Budget Plan Devastating to People with Intellectual Disabilities**

Rendell Budget Not Good - Senate Republican Budget MUCH WORSE

The Pennsylvania Senate is considering a state budget plan for fiscal year 09-10 that will be devastating for citizens with intellectual and developmental disabilities. Senate Bill 850 was unveiled to the public only days ago and is considered to be the Senate Republicans' alternative budget proposal to the one proposed by Governor Rendell in early February. Republicans are in the majority in the PA Senate and will have a great deal of influence in whatever plan is finally adopted before June 30th.

The Senate is expected to vote on SB 850 as early as this week. Not only would SB850 eliminate any new money to serve people either on the emergency waiting list or at risk of institutionalization, but it goes further by cutting funding for some people already in service.

The following is taken from a May 5th email from ODP Deputy Secretary Kevin Casey, which included an analysis of SB850's impact on ODP programs:

"Community Base Dollars- Reduced by \$12,117,000- This would require us to cut approximately 3000 individuals from service. As you know, base dollars are frequently used to give families and consumers who are without waiver services a small amount of service dollars to help them get by.

Waiver Services- Reduced by \$32,720,000 (state and federal)- This would eliminate the emergency initiative for next year(You will recall that we had planned to serve 760 people with those dollars in 2009/2010.), and require us to cut an additional 550 who are currently in service. This number is based on taking the cuts from the Consolidated waiver. If we took any of them from the PFDS waiver, the number would be much higher.

Autism services-Reduced by \$15, 286,000 (state and federal)- This would essentially gut both the Autism Waiver, and the ACAP program. We would have to cut 245 of the 500 people we had planned to serve."

As you can see, if SB850 gains any traction whatsoever, people with intellectual and developmental disabilities will be harmed. Please call, write, fax, or email your elected officials in Harrisburg immediately and urge them to oppose SB850's budget cuts for programs serving people with disabilities.
